FEB, 27 –MARCH 4 BOYS 5TH & BOYS 6TH (ENTER BY FEB. 10)

ENTRY INFORMATION: THE ENTRY FEE IS \$140 PER TEAM. TOURNAMENT FORMAT: THE FORMAT WILL BE EITHER ROUND-ROBIN, POOL-PLAY, OR BRACKET DEPENDING UPON THE NUMBER OF ENTRANTS. EACH TEAM WILL BE GUARANTEED A MINIMUM OF THREE GAMES.

RULES:

1. W.I.A.A. rules will apply at all levels. All games will be officiated by two certified WIAA officials.
2. Zone defenses are not allowed at the 5th and 6th grade levels, but are allowed at the 7th and 8th grade level.
3. At the 5th and 6th grade levels pressing will only be allowed during the last 2 minutes of a game. Pressing is allowed at the 7th and 8th grade levels at any time during the game.
4. At all levels, neither team may press if the point differential is 15 points or more.
5. Basketballs and First Aid Kits will be provided.
6. A 12-foot free throw line may be used for 5th grade girls games.
7. All girls games and 5th grade boys games will be played with the 28.5 basketballs. 6th, 7th, & 8th grade boys games will be played with regulation basketballs.
8. Each team will be afforded a minimum warm-up time of 5 minutes.
9. Admission will be charged as follows: Adults - \$2.00, Students & Senior Citizens - \$1.00, Children 5 and under – FREE. A \$5.00 Family Ticket will also be available.
10. Concessions will available for purchase. NO CARRY-INS!
