RULES:

1. W.I.A.A. rules will apply at all levels
2. These tournaments are for school teams only. No club teams or select teams will be admitted.
3. Players utilizing an underhand serve may take the first 5 serves from the 25-foot line. Remaining serves will be from the 30-foot line. Overhand serves must be from the 30-foot line.
4. Rally scoring will be used. The first two games are to 25 points with no cap. The third game will be played regardless of the outcome of the first two games. The third game is to 15 with a cap at 17.
4. When performing a serve, the server will get one re-toss per term of service.
5. Net height will be 7 feet.
6. Warm-up time shall be determined by the tournament official prior to each match and communicated to both coaches before the start of warm-ups.
7. Warm-up balls will be provided..
8. Admission will be charged as follows: Adults - \$2.00, Students & Senior Citizens - \$1.00, Children 5 and under – FREE. A \$5.00 Family Ticket will also be available.
9. Concessions will available for purchase. NO CARRY-INS!
